- C. *Distribution partners* - means any company that Yamgo Ltd has agreements with to distribute, promote, advertise or sell digital content.
- D. *Entrant's film* - means the film submitted as your entry to the Extreme Shorts Competition

Section A

- 1. This competition is open to anyone over the age of 16.
- 2. Entrant's can submit as many mobile movies as they like. The closing date for entries is 31 May 2007.
- 3. Entries must be submitted on MiniDV tape (PAL preferred), HD tape or AVI on CD-ROM. Please use the following settings for AVI files on CD-ROM:

- 4. Winners will be notified within 90 days of the closing date.
- 5. Films must be 30 to 120 seconds in length plus no more than 3 seconds for the title and 5 seconds for the credits. Any voice-over or narrative must be in English or dubbed / subtitled.
- 6. Entries must be submitted with the official entry form which is available to download at http://www.yamgo.com/extreme_shorts_competition.html
- 7. Yamgo is not responsible for any loss or damage to films. Yamgo will not return any films submitted. But Yamgo will replace any miniDV or HD tapes if the entrant provides a self addressed envelope. No responsibility is accepted for entries that are lost, delayed or damaged in the post. Entrant's will receive a confirmation email within 7 days of their film being received.
- 8. Entries which contain explicit sex and/or violence, and anything defamatory will be rejected. Yamgo reserves the right to reject any film without reason or notification.
- 9. The decisions of Yamgo on the identity of the winners are final and binding. No correspondence will be entered into.
- 10. Yamgo do not assume any responsibility for any misuse of intellectual property by the entrant.
- 11. These terms and conditions are subject to change without notice at the discretion of Yamgo.

Section B

By signing this form the entrant:

- 1. Grants Yamgo Ltd and its distribution partners the non-exclusive right to screen the film, pictures (inc. screenshots) and show the entrant's profile and film synopsis in any medium worldwide for the purpose of promoting the entrant, the entrant's work, Yamgo and the Extreme Shorts Competition.
- 2. Grants a non exclusive right to commercially exploit the content worldwide in whole or in part (may need editing for mobile devices). In such cases the entrant will receive a twenty five percent (25%) revenue share of net revenue received from the sale of the entrant's film. Any royalties due will be paid monthly when the cumulative (rolled over) payout amount exceeds one hundred (£100) GBP (payable in Pounds Sterling, Euro, US dollars, Canadian Dollars, Australian Dollars or Yen - using Paypal).

3. Warrants that they have acquired the rights and the clearances necessary for granting of rights to Yamgo and its distribution partners and that nothing in the entrant's film or pictures is libellous or defamatory or infringes on the performer's right, property rights, copyright, privacy rights or any other right whatsoever of any third party.
4. Warrants that any music included in the entrant's film is cleared for use as envisaged hereunder and no payments will be required by Yamgo or any third party in relation to music included in the content.
5. Warrants that no sums are payable by Yamgo or its distribution partners to any person whatsoever with respect to screening or showing the entrant's film for the purposes outlined in Clause 1.
6. Warrants that all persons appearing in the entrant's film are able to give and have given full consent to participation and to exploitation of the rights in the content envisaged hereunder.
7. Indemnifies Yamgo and its distribution partners against any loss or damages occurring out of failure to gain the appropriate clearances, defamation of another person etc.
8. Agrees that this licence is subject to the laws of England and the parties submit to the exclusive jurisdiction of the English courts.
